for the employment of:

- 1. One (1) research position Research Associate (equivalent to Assistant Professor, tenure track) in Humanities, Philology, at the Onomastics and Etymology Department. Research position is of definite duration (maternity leave replacement), full-time.
- **2. One (1) research position Research Assistant** on the project *Dynamic nature of specialized knowledge* (DIKA), Croatian Science Foundation, UIP-2017-05-7169. Research position is of **definite duration (4 years)**, **full-time**.
- **3. One (1) research position Research Assistant** on the project *The Croatian Web Dictionary Project (MREŽNIK)*, Croatian Science Foundation, IP-2016-06-2141. Research position is of **definite duration (4 years)**, **full-time**.

Obligatory requirement for 1: Lexicographic experience.

Conditions for 2 and 3: In addition to the general requirements for employment, candidates should meet the requirements stipulated by the *Law on Science and Higher Education* (Official Gazette No. 123/03, 105/04, 174/04, 02/07, 46/07, 45/09, 63 / 11, 94/13, 139/13, 101/14 and 60/15)

Obligatory requirements for 2:

- Completed graduate studies (Bachelor's degree) in Humanities (Philology), with average general mark high enough to enable enrolling into the doctoral program.
- Excellent English language skills

Additional qualifications for 2:

- awards, scholarships, excellence during studies, experience with research projects participation, knowledge of other foreign languages (in addition to English)

Obligatory requirement for 3: completed graduate studies (Bachelor's degree) in Information sciences with average general mark high enough to enable enrolling into the doctoral program of information and communication sciences.

Candidates shall send their application with a curriculum vitae (general information, information on education and previous employment, concise description of scientific and other work experience), a copy of the diploma of the relevant qualifications or academic degree, a copy of the decision on received research titles and a list of published scientific and professional papers.
